1	Remove existing neon and paint from the "Golden Liquor" sign. Prime and repaint sign cabinet. Fabricate and mount new 5" deep pan channel letters illuminated with white LED lights for "Golden Liquor" on both sides of the sign. Layout to be fairly similar to existing lettering. 1	Installation of the sign for either option on a new 6" pipe – 2' X 8' caisson required.	\$2970.00

The design is submitted to your company for the sole purpose of your consideration of whether to purchase the design or to purchase from Advantage Sign Company a sign manufactured according to these plans. Distribution or exhibition of the design to anyone other than employees of your company, or use of the design to construct a sign similar to the one embodied herein, is expressly forbidden. In the event that such exhibition occurs, Advantage Sign expects to be reimbursed \$1,000.00 in compensation for time and effort entailed in creating this design. (All original company logos are excluded from this clause.)**
- The purchaser as well as a representative from all governing parties pertinent to the approval process must sign all artwork before any work will commence.
- Any repairs, including electrical repairs, on existing signs are extra unless specified in this contract.
- When excavation is required, this contract assumes standard soil conditions. This contract does not include removal, repair or penetration of any obstructions including, but not limited to: rock, concrete, asphalt, brick groundwater, and water lines including sprinklers. Additional charges will apply if obstructions exist.
- **TERMS:** For jobs that require a deposit in order to start the job, the balance is due upon completion of the job even if Advantage Sign Company, Inc. is unable to install the sign due to conditions beyond our control. For net 30 accounts, interest of 1.75% per month (21% APR) will be assessed on the unpaid balance of past due accounts. For all other accounts, the interest will be assessed starting 14 days from the date of the invoice. In the event of default and/or litigation the prevailing party shall be entitled to reasonable attorney's fees and other costs of collection. All future work will be performed under the terms of this agreement unless modified in writing.
- For nonpayment, Advantage Sign Company, Inc. reserves the right to remove said sign(s) or file a mechanics lien, at its sole discretion.
- Customer agrees to jurisdiction and venue to be Colorado, County of Arapahoe in the event of litigation.
