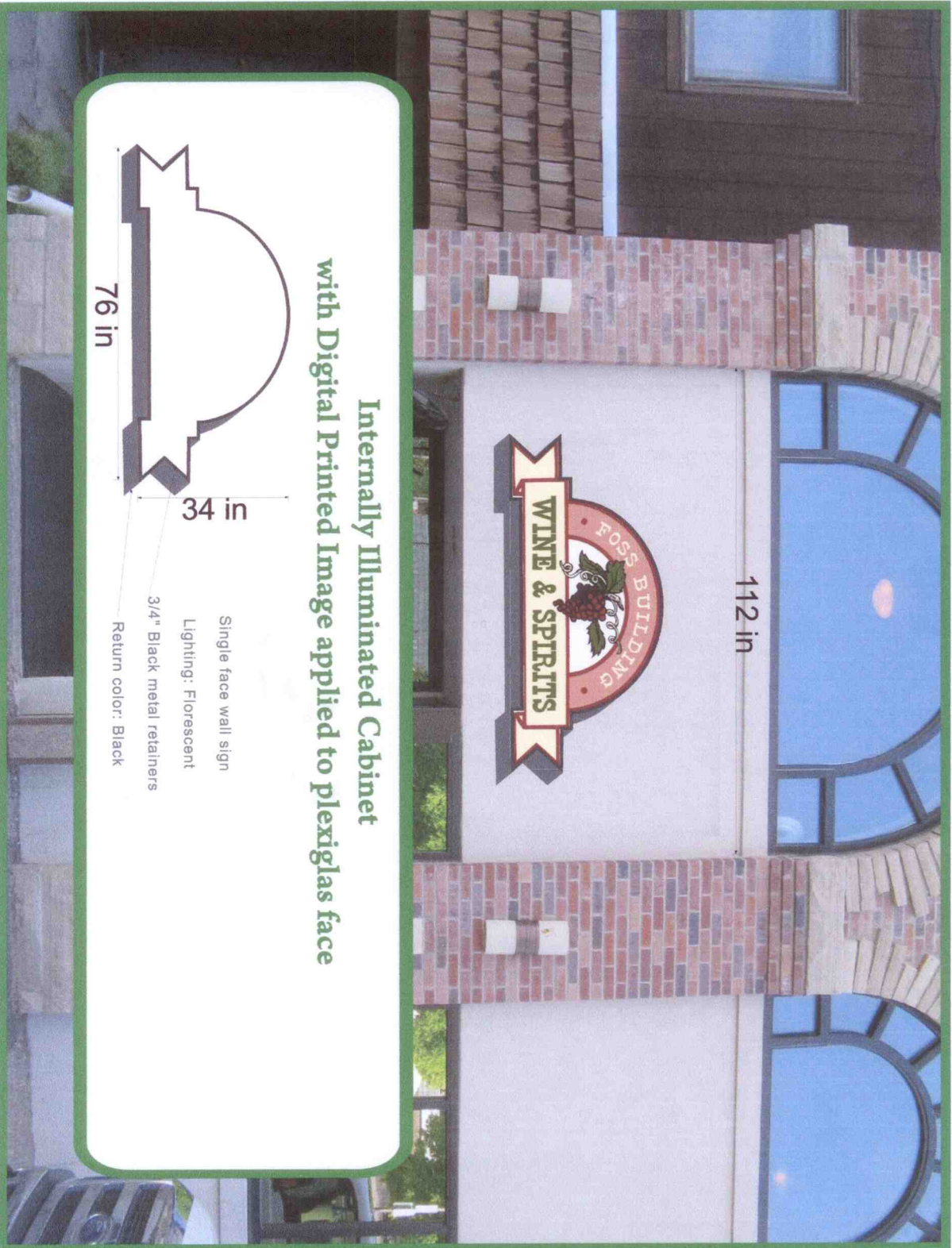
I have attached the different designs with the costs along with an invoice from the sign company for your information.

Foss Building Wine & Spirits appreciates your consideration of our request and I will happy to answer any questions you or the GURA Board may have.

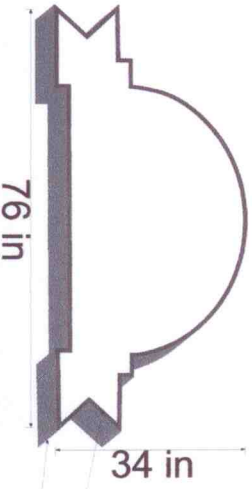

- Return color: Black

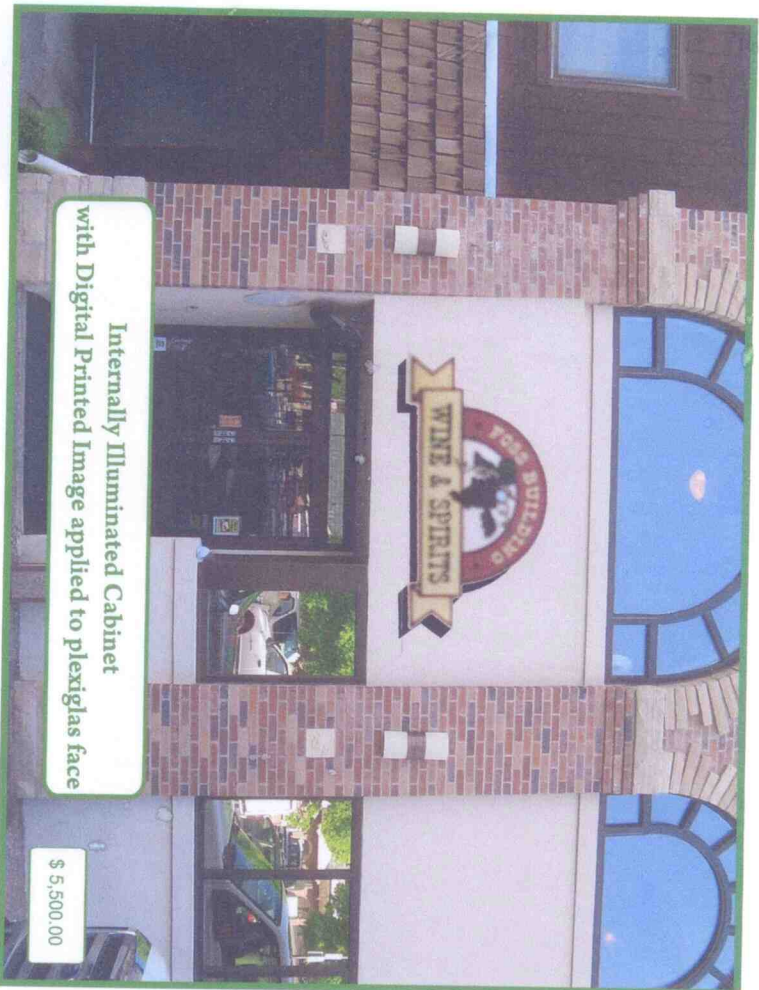

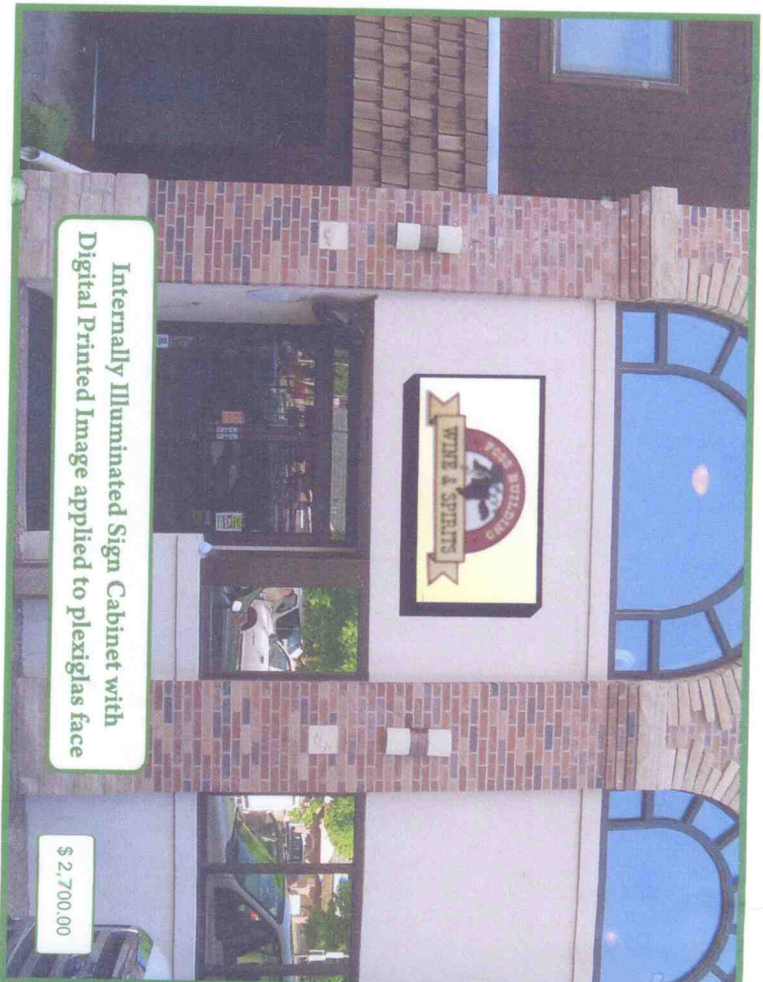

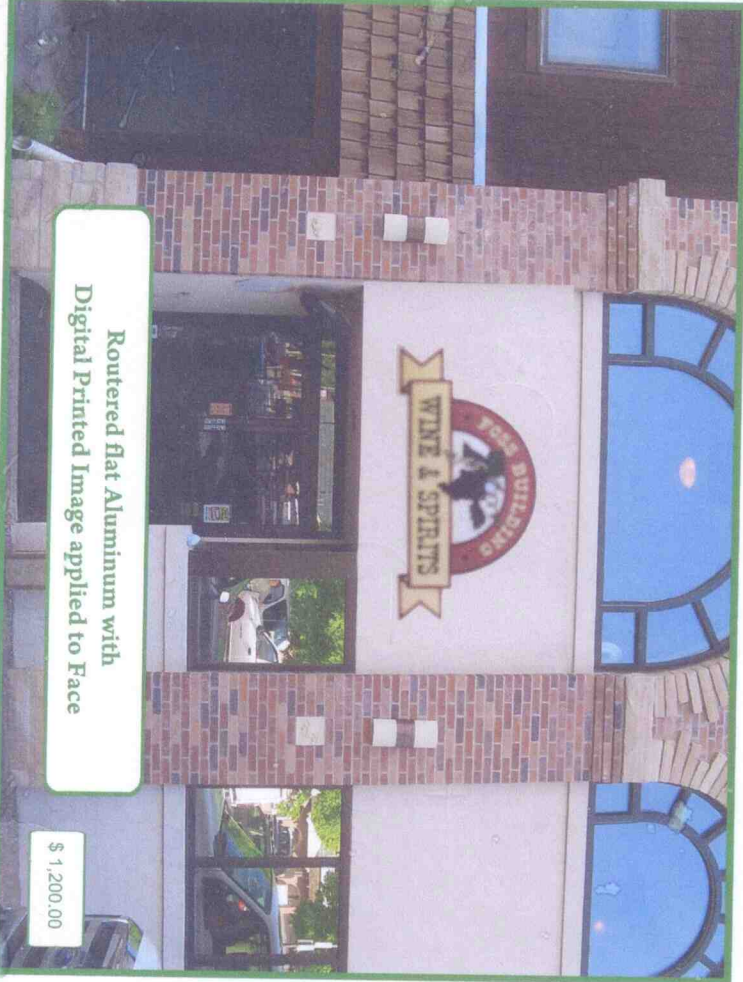
Internally Illuminated Cabinet
